GENERAL INFORMATION: SulfurPower has a Sulfur and Nitrogen base. Use SulfurPower as a foliar application. SulfurPower can also be impregnated on granular fertilizer at a rate of 1 quart per 300 pounds.

MIXING INSTRUCTIONS: Put 1/3 to 2/3 of total water volume in tank. **1.** Add pesticide(s) if desired and agitate until thoroughly mixed. **2.** Add SulfurPower and agitate until thoroughly mixed. **3.** Add adjuvant(s) if desired and agitate until thoroughly mixed. Fill tank with remainder of desired water. A jar test is recommended for evaluating compatibility of SulfurPower with multiple product mixtures.

USE RATES (FOLIAR): Soybeans: 1–2 qt/acre at V3 to R3. **Corn:** 1–2 qt/acre at V3 to VT. **Cereal Grains:** 1–2 qt/acre at stage 2 to stage 8. **Berry Crops and Vegetables:** 1–2 qt/acre as part of a regular spray program.

KEEP OUT OF THE REACH OF CHILDREN: Avoid contact with skin, eyes, and clothing. Avoid breathing spray mist. Wash hands thoroughly after use. **Personal Protective Equipment:** Wear long-sleeved shirt and long pants, socks, shoes, and gloves.
